Conclusion

The conclusion of this research can be seen as follows:

- There are some types of figurative language used in Shakespeare and Frost's poems. The types of figurative language which are found in Shakespeare's poem are simile, metaphor, hyperbole, and personification, while, types of figurative language which are found in Frost's poem are metaphor, hyperbole, and personification.
- Frost and Shakespeare's poem,in using figurative language, is they usually use nature as the comparison.
