

ABSTRAK

Penelitian ini bertujuan untuk mengetahui: 1) kinerja Komite Sekolah sebagai badan pertimbangan, 2) kinerja Komite Sekolah sebagai badan pendukung, 3) kinerja Komite Sekolah sebagai badan pengontrolan, 4) kinerja Komite Sekolah sebagai badan mediator. Rancangan penelitian ini bersifat studi evaluasi dengan menggunakan model evaluasi *goal oriented* dengan analisis data persentasi, menggunakan tehnik pengumpulan data angket dan wawancara.

Hasil penelitian ini menunjukkan bahwa: 1) kinerja Komite Sekolah Sebagai Badan Pertimbangan ditinjau dari indikator perencanaan program, pelaksanaan program dan pengelolaan sumber daya pendidikan memenuhi ketercapaian kinerja berhasil dengan skor persentase 81.81%, 2) kinerja Komite Sekolah Sebagai Badan Pendukung ditinjau dari indikator pengelolaan anggaran sumber daya, pengelolaan sarana dan prasarana, pengelolaan sumber daya memenuhi ketercapaian kinerja berhasil dengan skor persentase 77.27 %, 3) kinerja Komite Sekolah Sebagai Badan Pengontrolan ditinjau dari indikator perencanaan program, pelaksanaan program dan keluaran pendidikan memenuhi ketercapaian kinerja berhasil dengan skor persentase 77.27 %, 4) kinerja Komite Sekolah Sebagai Badan Mediator ditinjau dari indikator perencanaan program, pelaksanaan program dan pengelolaan sumber daya pendidikan memenuhi ketercapaian kinerja berhasil dengan skor persentase 84.85%.

ABSTRACT

The aim of the research were to know: (1) school committee performance as a advisory agency, (2) school committee performance as a supporting agency, (3) the school committee performance as a controlling agency, (4) school committee performance as mediator agency. Design of this research was an evaluation research with goal oriented evaluation model of analysis data percentage, by using questionnaire and interview to collect the data.

Result of the research were: (1) school committee performance as a advisory agency observed from program planning indicators, program implementation and educational resources management fulfilled the performance achievement with the score of 81.81%, (2) school committee performance as a supporting agency observed from resources management indicator, facilities and infrastructure management, budget resource management fulfilled the performance achievement with the score of 77.27%, (3) school committee performance as a controlling agency observed from program planning indicator, program implementation and outcomes of education program management fulfilled the performance achievement with the score of 77.27%,(4) school committee performance as a mediator agency observed from program planning indicators, program implementation and educational resources management fulfilled the performance achievement with the score of 84.85%.
