Background

It can be said that discrimination is unequal treatment against individual, or group, based on something, usually categorical, or unique attributes, such as based on race, ethnicity, religion, or membership of social classes. The term of discrimination is usually to describe an actions of the dominant majority party in relation to a weak minority, so that it can be said that it is immoral behavior and democracy.

In discrimination, there is racial discrimination. According to CERD Article 1 (1965) (as cited in Weiwie, 2004, p. 8), defines racial discrimination as

any distinction, exclusion, restriction or preference based on race, color, descent or national or ethnic origin which has the purpose or effect of nullifying or impairing the recognition, enjoyment or exercise, on the equal footing, of human rights and fundamental freedoms in the political, economic, social, cultural or any other field of public life. In my opinion, it is a discrimination against someone or group based on the race can be happen in public life.

American is one of country that did discrimination included racial discrimination. Yourdanian (2012), discusses about discrimination in America in the 60's. Although in the 60's was ever a Civil Rights Movement that gives equals rights to blacks but the racial discrimination still happened to blacks, especially in the South America. Blacks also often fought against the racial discrimination they receive. This racial discrimination exists in human life.

Because of this discrimination and racial discrimination is found in our social lives. Many literary works that take the themes that exist in people's lives. This movie show the racial discrimination did happened to black in daily life.

The meaning of Missus Walters's statement is Hilly angry when she must used the same bathroom that used by nigra. This is an act of racial discrimination that given by Hilly, where she shows the racial discrimination with does not want to used the same bathroom with black people.

In 01:21:00,856 --> 01:21:02,950, we can see scene seating separation in black and white on the bus. It means the white don't want to sit together with black. White people believes black people spread of diseases.

As we know, in this movie, racial discrimination is prominent conflict but I want to show and describe how the racial discrimination happened to black people and also what is the racial discrimination. In this movie, Hilly is the person always does the racial discrimination to black people and she make all people to refuse black uses the same bathroom with the white.
