This part discussed about conclusion and recommendation for the reader about Conversational implicature and Conventional implicature in VOA news.

### **Conclusion**

Then were several Economic news that I found in Conversational implicature. In additional, based on 9 data that analyzed, I got similar explanation, they were needs some question to complete the title of VOA news, it was because, there was not dialogue on the title, however according to Grice (1975) even there was no dialogue. We could analyze the sentence based the context. A dialogue if the contexts appear more questions. 9 data were founded in economic category from VOA news that I got, shows that there were not dialogue in VOA news, but the title might analyzed by the contexts.

Furthermore, 9 data in economic category in VOA news that I got and have analyzed are: Talks Collapse; Ukraine Halts Purchases of Russian Gas, Greece: No choice but to propose 'Harsh' reforms, Kenya, Uganda Agree on Route for Oil Pipeline, Capital Control Means Greeks Can Click, Not Buy, Russia Wants to Question Ex-oil Tycoon Over '98 Murder, Roller Coaster Ride Far From Over for Chinese Stocks, KFC Becomes First US Fast-food Chain in Myanmar, Iran's Carpet Weavers at Work, Anticipating Jump in Exports and Greece Teeters on Brink of Euro Exit as Referendum Approaches.

Not only in economic, I also got similar explanation in health category, there was no differential of explanation with economic news, they also did not have dialogue. They are: Ebola Returns to Liberia, Pakistan Heat Wave Kills 1,000, Sparks Anger, South Korea Reports One New MERS Case, Report Urges Accelerated AIDS Fight, Scientists Find Gene Secret That Lets Poppies Make Morphine, China Pact Seen Advancing Knowledge of Heart Health, Study: Drug

Reverses Condition That Attacks Pigment in Skin, and Newborn Eye Movement Predicts Childhood Behavior Problems.

Over all, the explanation about Conversational implicature that I analyzed in both categories economic and health need more developing question complete the topic. However thus, both of categories were include in conversational implicature.

In conventional implicature, I only got 3 data in both categories between economic and health. In this analysis a little data were founded then conversational implicature. Moreover, based on the data, they were include in conventional implicature because there have clause "As" in the topic. Not only "As" clause that in conventional implicature, however Adverbs, Already, also, barely, either, only, scarcely, still, too, yet. Connectives have but, nevertheless, so, therefore, yet. Implicative verbs: Bother, condescend, Continue, deign, fail, and manage. Subordinating Conjunctions: Although, despite. (The fact that), even though. Bach (1991).

In conclusion, based on the analysis, there were more data in conversational implicature than conventional implicature. Based on Conversational implicature 9 data in economic and 8 data in health news. whereas, in conventional implicature 1 data in economic and 2 data in health. Thus, it can be concluded that more implicature were applied in VOA news based on economic and health categories is conversational implicatures, in addition were only a little bit. However, this study was focused on economic and health news. in the next study I hope more researcher to developed the study in order this study were perfect.

### **Recommendation**

Analyzing implicatures especially in Conversational and Conventional is not only analyzing Economic and Health categories in VOA news, but also there are many others categories in VOA news that can be analyzed. Therefore, hopefully, the research should continue

in more analyzing about Implicatures especially in Conversational and Conventional, such as Politics, Education, Sports, Entertainment, and Technology.

In analyzing implicature especially in Conversational and Conventional which Economic and Health categories are the object to analyze based on implicature analysis is not complete yet. There some aspects are not complete including in this theory, like analyzing the Conversational, and Conventional. Therefore, it would be better if the research will continue with import more categories.
