# **Conclusion and Recommendation**

This chapter shows the conclusion and suggestion of this research. The conclusion is to conclude the main points of this research. It is obtained from the analysis in chapter four. Meanwhile, the suggestion is advices this research as well as to lead and guide other researchers who are conducting a similar study.

## Conclusion

After analyzing the data, the researcher can conclude that there are <u>two types</u> of blending word. The first is <u>abbreviated compound blending</u> and the second is <u>proper blending</u>. Based on the findings, the researcher found 29 words included in abbreviated compound blending, then 48 words belong to proper blending. It indicates that the process of the blending word which proper blending is the most common process that the researcher found in the list of Wikipedia portmanteaus particularly the general terms. The using of blending which is proper blending can be used by the people to formulate a simple activity in speaking because the meaning of source or base words are related, for example; the word *prosumer* is formed by words *professional* and *consumer*. In this case, the word *prosumer* syntactically follows the meaning of the base words, thus the word *prosumer* imply as a person who has highly skill to buy something good.

### Recommendation

Based on the conclusion previously, the researcher would like to give suggestion about this research which have relation to the analysis of blending particularly blending words that available in some lists of Wikipedia portmanteaus. For further research, the researcher suggest for the next researcher to write a discussion more comprehensive about blending word formation process not limited on the list of Wikipedia portmanteaus terms, however can be getting the blending word in advertisement, newspaper, film and even in conversations of people. Occasionally, the researcher also recommend to the next researcher who concern in the similar study can be consider in the meaning of blending words, in order to make the research of this study developed.

Essentially, the researcher realizes that this research is still far from perfect and still need more improvement for better understanding in this study. It is expected that the next researcher who interested in the same study can take this as the guide in order to provide more qualified result of research. It is because knowledge is always and gradually developed and it is supposed to be developed.
