CHAPTER I

INTRODUCTION

Basic Consideration

Sociolinguistics is one of linguistics branches which discusses how individual speakers use language, how people use language differently in different town or regions, how nation decides what languages will be recognized in courts or education (Meyerhoff, 2006:26). From the statement, I ensure that people (speakers) have each style when they use language because people are different. And then, people (speaker) communicate each other based on circumstance. They caused language variation. The variation occurred because of people's style in using language. According to Holmes (2013), "style is sometimes determined by the function which language is used for." So that our style in using language depend on circumstance, and then people should choose a compatible style to communicate in appropriate situation and condition. this study uses term "style" in analyzing one of character namely Atticus Finch in "To Kill a Mockingbird" Novel written by Nelle Harper Lee.

The novel is one of literary work and it is well known enough. It has either long story or dialogs in the novel. This study discovers language style that available in the novel. Exactly types of style that available in dialogs. "To Kill a Mockingbird" is the title of the novel and it will be discussed. The novel written by Nelle Harper Lee and it was published in 1960. In 1961, it achieved Pulitzer Prize and has

become a classic of modern American literature. It is even widely taught in schools in the United States with a lesson that emphasizes tolerance and decries prejudice. The important thing of this novel is that it contains an educational value, how a single parent was to raise up and educate his children with his own paragon until they will turn to be an honorable person, fight for truth without being afraid and take care of poor people.

Atticus Finch in "To Kill a Mockingbird" novel is the character to be discussed. His role as a single parent for both of children namely Jean Louis Finch and Jeremy Atticus Finch. Atticus Finch is a character who has paragon and experience in all of his work and family. Hence, he is an appropriate character to be discussed because he has a lot of dialogs in the novel which is supporting the research.

Linguistics is a knowledge that must be learned and practiced because human needs language as a tool of communication. Sociolinguistics is part of linguistics and it is learning about the relationship between language and society. He has no money" this sentence is not formal style because formal style must have complete structure and frozen, consultative even intimate neither because of frozen usually in the ceremony, consultative usually in sector administration and intimate usual conversation between a best friend and strong relationship. In this study, researcher will describe types of style that are used by Atticus Finch.

Research Question

Based on previous brief explanation, the writer has one question, that is:

Research Objective

Concerning with the research question above, this research intended to achieve one objective:

 To find out types of style that are used by Atticus Finch in "To Kill a Mockingbird" novel.

Scope and Delimitation of Research

This study analyzed about types of style that are used by Atticus Finch. This study used Atticus Finch's dialogs as data that are available in "To Kill a Mockingbird" novel. Therefore, this study is limited to types of style that are used by Atticus Finch along with they will be analyzed according to the title of this mini-thesis.

a. Theoretically
