CONCLUSION AND SUGGESTION

Conclusion

This chapter discusses the conclusion and suggestion. Conclusion is drawn after getting research finding. Then, suggestion leads further researchers who are interesting in doing similar research.

After analyzing the types of maxims based on Cooperative Principle and the meaning of each utterance contains the Grice maxim used in “Beautiful Mind” movie, the researcher would like to draw the conclusion as follow:

1. The researcher analyses the maxims based on Cooperative Principle consisting of maxim of quantity, maxim of quality, maxim of relation, maxim of manner in the movie script. There are two kind of data; in line the maxims and flouting the maxims. The researcher found 16 utterances, which is containing in line of maxim of cooperative principle and 19 utterances, which is containing flouting maxims of cooperative principle. 7 utterances which contain in line of quantity maxim, 4 utterances contain in line of quality maxim, 4 utterances contain in line of relation maxim, 2 utterances contain in line of manner maxim, 3 utterances contain the flouting of quantity maxim, 3 utterances contain the flouting of quality maxim, 8 utterances contain the flouting of relation maxim, and 5 utterances contain the flouting of manner maxim. From the data collection there is maxim quantity and flouting maxim of relation which is the most frequently found in the utterances of the movie.
2. The researcher also explains the meaning of each utterances contain of Cooperative Principle in the movie script. In each utterance, it has been explained the meaning of each

utterance and the explanation of the maxims in line and maxims flout based on Cooperative Principle. It can be seen that the movie researcher writing could be fun and attractive. If the whole conversations contain formal dialogues, the movie will be in linear boring story. It describes that in the real life, people often use so many words, irrelevant statements, ambiguous sentences, untruthful answers in the perspective of Cooperative Principle.

Suggestion

Based on the explanation, to close this graduating paper the researcher proposes some suggestion for the next researchers who are interesting in doing similar research. This research will give contribution to comprehend the maxim of cooperative principle and the flouting of cooperative principle. Hopefully, the research gives inspiration and guidance for the next researcher to be careful in doing research, so that, the result is being better than this. For the next researcher, this “Beautiful Mind” Movie can be good reference if they want to look for the examples in line maxim and flouting the maxim of cooperative principle.

For the students’ university who wants to know more about Cooperative principle, they can use this skripsi as the guidance for them to know about in line and flouting of conversational maxim, which proposed by Grice. This skripsi will be more useful for the students’ university more easily to identify the line and the flouting of cooperative principle, which is existing in our daily life.
