The meaning of the poem *The Sick Rose* is about a woman with a broken heart because of love, she was infected by a dark love but she was not realized, she hopes to find happiness in the hereafter.

While the meaning of the poem *Ah Sun Flower* is about a young man who is looking for a better life, vigorously until finally finding true happiness. Blake prefers to use flowers to represents the person as an object in the poems.

The conclusion was that although the two poems titled with the name of flowers, but William Blake uses more than three figurative languages in these poems. The researcher has analyzed the meaning contained in the poetry of Blake by sight alone, or structurally, without connecting the intrinsic elements in the poem.

1.
