CHAPTER V

Conclusions and Suggestions

This chapter discusses the conclusions and suggestions of research based on the findings result about students' problems in listening comprehension at students of MAN Batudaa especially class X MIA 1.

Conclusions

Listening is a process of transferring information from the speaker to listener. Through listening, students can get much information and also, they can construct new knowledge from the interaction between their lesson and the background knowledge.

Based on the result of observation and interview, the researcher finds that the result of the students' problems in listening comprehension based on the indicators, most of students have problems in listening. The researcher concludes that the students have problems about vocabulary. In vocabulary, most of students have lack or limited vocabulary, it makes them cannot understand the contents of the text. also, the students have problem in pronunciation of the speakers. Unclear pronunciation of speaker is considered as a source of listening problems. Many students think that unclear pronunciation is causedby the difficulty in understanding their English listening lesson. For example, to distinguish the meaning of "she/he", "three/tree" etc. actually the speaker pronunciation is clear, but some of the students have trouble while their listening. It is caused by their less concentration, less understanding about the concept, less of practice, the environment, and the audio tape is broken. It is hoped that the results of this study will contribute to improve the teaching and learning in the field of listening comprehension in MAN Batudaa.

Suggestions

Based on the results of the study, there are some suggestions;

Suggestion for teacher, this research will help teachers in applying the appropriate application of learning models to address the problems that is faced especially in teaching listening comprehension.

For students, students have to practice more in listening English conversation, English music, and watching English movie. Usually, autodidact can help students in increasing their vocabularies of English and they can be able to pronounce English language well and correctly. In addition, for others, it is as a guidance to gain knowledge about the selection of appropriate learning models with the learning material.

Limitation of Research

This research only focused to find out the students' problems in listening comprehension. So, this research has limitation. The limitation of this research is this research did not use any media or strategy to improve students' ability in listening.
