Conclusions

Based on the result findings and discussion, there are 15 data which have an implicit meaning that was analyzed and classified into the types of meaning based on Leech (1981,p.23) theory and supported by others theory in analyzing the meaning. From the steps of analyzing the data through findings and discussion, it shows the result which belongs to six of seven types of meaning. Those are conceptual meaning, connotative meaning, social meaning, affective meaning, reflected meaning, and collective meaning. One of the types of meaning that was presented by Leech thematic meaning, is not found in Muhammad Ali's quotes.

Muhammad Ali is known as the Greatest Boxer who crown the heavy weight boxer that leaves good and bad impression around. He is the one who talked the most during his era until the end of his life. Ali produce some quotes which describe his life journey inside and outside the ring. His quotes give a big impact to the other and present an implicit meaning that needed interpretation for gaining the message properly.

Suggestions

According to the findings of the research, there are some suggestion for the reader and the next researcher who will conduct the same research who study about meaning. It is defined from this study that an implicit meaning that contained in Muhammad Ali's quotes shares the six of seven types of meaning. It is expected to guide the next researcher who will conduct the similar research in semantics field especially in analyzing meaning to excavate more

deeply the other types of meaning with different object in order to guide and give more resources the student's in understanding the study of meaning.
