Conclusion

This research observes the types of lexical ambiguity which takes place in movie entitled Hotel Transylvania II. Thus, this research found the various meaning of the ambiguous words dealing with the context in the movie Hotel Transylvania II. This study used theory of Ullman (1977) which defined lexical ambiguity into two types, there are polysemy and homonymy.

This study have found 14 data contained lexical ambiguity from 14 utterances. Therefore, the whole 14 data are categorized as polysemy and none of the data that categorized as homonymy.

Summing up the results, it can be concluded that in movie entitled Hotel Transylvania II take place the phenomenon of lexical ambiguity which divided into two types. Consequently there are polysemy and homonymy as the types of lexical ambiguity. But the whole data totally showed that all of the data is only counted as the type of polysemy.
