Doctor Mortimer is so sure that the Hound is responsible for Sir Charles's death that he doesn't think it's worthwhile for Holmes to investigate further. He just wants to know what Holmes thinks he should tell the new heir to Sir Charles's estate, Sir Henry Baskerville. After all, he wants Sir Henry to be comfortable in his new home, and he doesn't want to make Sir Henry another victim of the Hound's appetite for Baskervilles. Therefore, the initial situation is one of danger and the supernatural. Doctor Mortimer believes that this is a ghost story, even though Holmes is a supremely practical and rational detective.

The conflict slowly happen when doctor Watson and Sherlock holmes starting their mission in Devonshire. For example conflict between Stepleton and Baskervilles family, Stepleton is a local naturalist in devonshire, he wants to take of the Baskervilles family owned land, so that he uses a dog that is very frightening to kill another Baskervilles heirs Sir Henry Baskervilles.
