ABSTRAK

Penelitian ini bertujuan untuk mengetahui kerja sama BPD dengan pemerintah desa dalam hal pembangunan infrastruktur yang ada di desa dan kendala-kendala dalam kerjasama BPD dengan pemerintah desa.

Penelitian ini menggunakan metode penelitian empiris. Metode dalam pengumpulan data menggunakan metode observasi, wawancara dan dokumentasi. Sedangkan Teknik Analisis Data melalui tahapan penyajian data dan penarikan kesimpulan.

Berdasar hasil penelitian, maka peneliti memperoleh bahwa kerjasama BPD dengan pemerintah desa belum terlaksana dengan baik, Hal ini terlihat dari adanya keluhan mengenai pembangunan jalan yang tidak merata, hanya di bagian tertentu. Selain itu ada beberapa faktor penghambat BPD dalam melaksanakan tugas sesuai tupoksinya. Yaitu, kurangnya partisipasi anggota yang telah diadakan oleh pihak BPD sehingga tidak maksimal peran BPD dalam hal pelaksanaan pembangunan.

ABSTRACT

This study aims to determine the cooperation between the village consultative body and the village government in terms of infrastructure development in the village and the obstacles in the cooperation between the BPD and the village government. This study used empirical research methods. Data collection was conducted using observation, interviews, and documentation. At the same time, the data analysis was conducted through the stages of data presentation and concluding.

Based on the results of the study, the researchers found that the cooperation between the village consultative body and the village government has not been implemented properly. It can be seen from the complaints about the uneven road construction, only in certain parts. Besides, there are several inhibiting factors for the village consultative body in carrying out its duties according to its main function. Namely, the lack of member participation that has been issued by the village consultative body so that the village consultative body role is not optimized in terms of implementing development.
