Abstrak

Firmansyah Blongkod, "Hubungan antara Sikap Pengambilan Resiko dan Kemampuan Berbicara Mahasiswa Didepan Umum dalam Presentasi di *International Student Conference*. Pembimbing I Prof. Dr. Hj. Moon Otoluwa, M.Hum dan Pembimbing II Novriyanto Napu, M, Appling, PhD.

Tujuan dari penelitian ini adalah untuk mengetahui hubungan antara pengambilan resiko dan kemampuan berbicara mahasiswa di depan umum pada *International Students Conference*. Penelitian ini berfokus pada pembicara ILC dalam berbicara di depan umum seperti yang dinyatakan pada buku H. Douglas Brown (*Principles of Language Learning and Teaching*). Penelitian ini menggunakan metode campuran kuantitatif dan kualitatif yang dilakukan di *International Students Conference* mahasiswa Pendidikan Bahasa Inggris tahun akademik 2016. Dalam mengumpulkan data peneliti pertama-tama menggunakan kuesioner untuk mengukur pengambilan resiko dan tes lisan untuk mengukur kemampuan berbicara menggunakan adaptasi dari rumus yang dikemukakan oleh Sigit (1999, sebagaimana dikutip dalam Fhonna, 2014) untuk melihat hubungan antara sikap pengambilan resiko dan kemampuan berbicara di depan umum, dan kedua melakukan wawancara untuk mengukur faktor-faktor yang menghubungkan 2 variabel tersebut. Hasilnya, hipotesis penelitian diterima. Hal ini sesuai dengan kriteria pengujian t_{hitung} sebesar 4,3593 sedangkan tabel distribusi diperoleh t_{table} sebesar 2,0932. Nilai t_{count} lebih besar dari t_{table} ($4,3593 > 2,0932$). Dengan demikian, hipotesis H_0 diterima, dan H_1 ditolak. Hal tersebut membuktikan adanya hubungan yang kuat antara sikap pengambilan resiko dengan kemampuan berbicara mahasiswa didepan umum pada *International Students Conference*. Berdasarkan hasil perhitungan rumus korelasi r pearson product moment antara variabel X dan variabel Y diperoleh $r = 0,81$ dan koefisien determinasi pengambilan resiko terhadap kemampuan berbicara mahasiswa didepan umum adalah $r^2 = 0,7768$ atau 77,68 %. Selain itu ada 4 faktor yang menghubungkan sikap pengambilan resiko dengan kemampuan berbicara didepan umum antara lain persiapan mental, persiapan media dan materi, fokus dan keberanian diri.

Abstract

The objective of this research was particularly to find out the correlation between the students' risk taking and their public speaking ability in international students conference. This study focused on the ILC's speaker in public speaking as stated by H. Douglas Brown book (Principles of Language Learning and Teaching). This research was examined by using mix quantitative and qualitative method conducted at the international students conference on students of English Educational Department academic years 2016. In collecting the data the researcher firstly used questionnaire to measure their risk taking and oral test to measure their speaking ability further used adaptation of the formula conducted by Sigit (1999, as cited in Fhonna, 2014) to see the correlation between risk taking personality and public speaking ability and secondly used interview to measure the factors correlating these 2 variables. As the result, the hypothesis of the research was accepted. It appropriates with criteria testing the t_{count} as big as 4,3593 whereas table distribution t_{table} obtained 2,0932. The value t_{count} bigger than t_{table} ($4,3593 > 2,0932$). As a result, hypothesis H_0 is accepted, and H_1 is rejected. It had been proved there was a strong correlation between students' risk taking personality and students' public speaking ability in presenter of international students' conference. Based on the result of calculation of r Pearson product moment correlation formula between variable X and variable Y are obtained $r = 0,81$ and determination coefficient of risk taking towards students' public speaking ability was $r^2 = 0,7768$ or 77,68 %. Moreover, there were 4 factors correlate the students' risk taking personality and their public speaking ability, those were mental preparation, media and material preparation, focus, and self-courage.
