Abstract

This research investigates the flouting maxim cases in the movie *Doctor Dolittle* directed by Betty Thomas. The aim of this study is to illustrate the types of flouting maxim that occurred between John as the human character in the chosen movie and some of the supporting characters which are animals. A qualitative descriptive method was employed in analyzing the data findings. In collecting the data, the researcher observed the movie, identified the flouting cases between the chosen characters, and gathered them through note-taking. After the data were selected, the researcher categorized them based on the types of flouting maxim by using Grice's theories of Cooperative Principle and other experts' theories about flouting maxim. As a result, 22 data were found performed by John and the animals. It included four types of flouting maxims: flouting maxim of quantity, flouting maxim of quality, flouting maxim of relevance, and flouting maxim of manner. Based on the analysis, the flouting maxim that occurred between John and the animals happened not because of their status as different creatures, yet it is due to certain situations that made them decide to flout the maxims.

Abstrak

Penelitian ini menyelidiki pelanggaran maksim di Film Doctor Dolittle yang disutradarai oleh Betty Thomas. Tujuan dari penelitian ini adalah untuk mengilustrasikan jenis pelanggaran maksim yang terjadi antara John sebagai tokoh utama manusia dalam film yang dipilih dan beberapa tokoh pendukung berupa hewan. Penelitian ini menggunakan metode deskriptif kualitatif untuk menganalisis data. Selain itu, pengumpulan data dilakukan melalui bebarapa tahapan, yakni peneliti mengamati film, mengidentifikasi kasus pelanggaran di antara karakter yang dipilih, dan mengumpulkannya melalui pencatatan. Setelah data terpilih, peneliti mengkategorikan data tersebut berdasarkan jenis-jenis pelanggaran maksim dengan menggunakan teori Prinsip Kerja Sama Grice dan teori para ahli lainnya tentang pelanggaran maksim. Hasil penelitian menunjukkan bahwa terdapat 22 data pelanggaran maksim yang dilakukan oleh John dan para hewan, yang mencakup empat jenis pelanggaran maksim, yakni pelanggaran maksim kuantitas (flouting maxim of quantity), pelanggaran maksim kualitas (flouting maxim of quality), pelanggaran maksim relevansi (flouting maxim of quality) dan pelanggaran maksim cara/pelaksanaan (flouting maxim of manner).
