Chapter 5: Conclusions and Suggestions

This final chapter discussed the conclusion of the research. The chapter also gives some recommendations gotten from the research result.

Conclusions

Based on the data and discussion gathered in the previous chapters, it can be concluded that the implementation of the dictation technique in the teaching and learning process of listening enriched the students' listening skill. Dictation helped the students in learning process. Dictation technique able to improve students ability in listening. It can be seen from the data analysis that the students score in pre-test and post-test was significant differences, which is means students achievement after their applied dictation technique in learning process. Total score in pre-test, the students obtained is 866. Meanwhile, total score in post-test, that students obtained is 1261. It was totally proved the differences between pre-test and post-test data result. From this research, the hypothesis got $t_{count} = 17.41$ and $t_{list}=2.09$, therefore it was accepted if $t_{count} > t_{list}$. The hypothesis was dictation technique can enriched students listening skill. Means that, there was different between the result before and after being taught by using dictation technique, this technique gave positive impact in learning process and increased students learning English listening skill

Suggestion

In this study, the researcher would like to give a suggestion. In teaching and learning process the teacher should be smart in choosing technique, it aims to make the learning objectives can be achieved. Trough the technique the students can enjoy the class in order to make students easy in received the material. Through this section, the researcher give suggestion in learning process teacher better to use dictation technique especially in listening skill, because this technique can make students more active, and effective, also can improve students' ability, this approved by the researcher. On the other hand, teacher have to pay attention to the students' condition in class, it will help teacher to find the appropriate method in teaching and learning process. And for the next researcher who want to conduct study about dictation technique more pay attention about the technique, the researcher had to manage the class well because the class will be noisy in learning process.
