Chapter V: Conclusions and Recommendation

This chapter presented the conclusion of the researcher which conducted. And the researcher is supposed to give a few recommendations for the reader.

Conclusions

Based on the result of research and discussion about students' ability in reading comprehension by using the DRTA method can be summarized as follows:

The DRTA method can improve students' ability in reading comprehension. It can be seen from the data analysis that the students score in pre-test and post-test was significant differences, which is means students achievement after their applied DRTA method in the learning process. The total score in the pre-test, the students obtained is 136. Meanwhile, the total score in the post-test, which students obtain, is 221. It was proved the differences between pre-test and post-test data results. From this research, the hypothesis got $t_{count} = 10.63$ and $t_{list} = 2.101$, therefore it was accepted if $t_{count} > t_{list}$. The hypothesis was DRTA method can improve students' ability in reading comprehension. Means that, there was different between the result before and after being taught by using the DRTA method, this technique gave positive impact in the learning process and increased students reading comprehension.

Recommendation

Based on the result from data analysis, it can be seen that the teacher who want to utilize DRTA method in class, they should consider the characteristic of the students first. This method divided into three step that require students comprehension and also need more time to manage all students. Moreover, the use of DRTA method can be considered because it useful in learning process. Through the three steps, students more active in class and look enthusiastic.

For the next researcher who are interested in teaching reading in junior high school, they can get the basic information from this study to do the further research.
