Literary work is a way to express human expression such as feeling, thought, ideas, and imagination. Mostly, it talks about the real situation that happens in society which has moral values that can be applied in real life. In the Elizabeth Rudnick's *Maleficent* novel, there are two main character, Maleficent and King Stefan, where the depiction of the two main characters was not as it seems. As the representation of real situation in society, this novel created multiple perceptions. So, this study questions how are Maleficent and King Stefan characters depicted in *Maleficent* novel based on the deconstruction theory of Derrida. This research uses qualitative research method by using Saussure's binary opposition of structuralism and Jacques Derrida's deconstructive approach. By using structuralism strategy, it is found that the characters were centralized into King Stefan as good and Maleficent as bad. Meanwhile, by using deconstructive strategy, it is found that King Stefan character was the true evil and Maleficent had paradox character.

Karya sastra merupakan cara untuk mengungkapkan ekspresi manusia seperti perasaan, pikiran, gagasan, dan imajinasi. Sebagian besar membahas tentang situasi nyata yang terjadi di masyarakat yang memiliki nilai-nilai moral yang dapat diterapkan dalam kehidupan nyata. Dalam novel Maleficent karya Elizabeth Rudnick terdapat dua tokoh utama yaitu Maleficent dan King Stefan, dimana penggambaran kedua tokoh utama tidak seperti yang terlihat. Sebagai representasi dari situasi nyata di masyarakat, novel ini menciptakan berbagai persepsi. Maka, penelitian ini mempelajari tentang bagaimana karakter Maleficent dan King Stefan digambarkan dalam novel Maleficent berdasarkan teori dekonstruksi Derrida. Penelitian ini menggunakan metode penelitian kualitatif dengan menggunakan pendekatan strukturalisme oposisi biner Saussure dan pendekatan dekonstruktif Jacques Derrida. Dengan menggunakan strategi strukturalisme, ditemukan bahwa karakter baik dipusatkan pada King Stefan dan Maleficent sebagai yang buruk. Sedangkan dengan menggunakan strategi dekonstruktif, ditemukan bahwa karakter King Stefan adalah yang paling jahat dan Maleficent memiliki karakter yang paradoks.
